ARTWORK LOAN AGREEMENT

This Agreement, made this __ day of _____, _____, by and among the CITY OF LARGO, (hereinafter "LARGO", and _____ (hereinafter "LOANING PARTY"):

WHEREAS, LARGO desires to enhance the appearance of certain public facilities by displaying the artwork of the LOANING PARTY; and

WHEREAS, the LOANING PARTY wishes to have his/her artwork publicly displayed at such facilities; and

WHEREAS, the LOANING PARTY desires to loan to LARGO, his/her artwork in order to have such artwork publicly displayed; and

WHEREAS, LARGO agrees to display such artwork subject to the conditions herein.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, and in reliance upon the respective representations and warranties herein, the parties agree as follows:

1. LOAN

The LOANING PARTY agrees to loan, and LARGO agrees to display, the LOANING PARTY'S artwork subject to the terms hereof.

2. LOCATION

- (a) LARGO, or its duly authorized representatives, shall be exclusively responsible for the selection and siting of the loaned artwork.
- (b) On occasion, the CITY OF LARGO may, at its sole discretion, transport the loaned artwork to and from other city facilities for display.
- (c) LARGO will not be responsible, in any manner, for the loss, destruction or damage of any of loaning parties artwork resulting from, or related to, any transport thereof.

3. INSURANCE

- (a) LARGO will not provide insurance for any artwork on loan, nor will it be responsible, in any manner, for the loss, destruction, or damage of any artwork on loan, whether insured by the LOANING PARTY or not.

(b) The LOANING PARTY shall be solely and exclusively responsible for procuring and maintaining insurance for any and all artwork on loan to LARGO, should the LOANING PARTY deem such insurance either necessary or desirable.

4. TERMINATION

The parties agree that this loan arrangement may be terminated by either party within thirty (30) days notice. Following termination of this loan agreement, should the LOANING PARTY not retrieve or otherwise provide for removal of his/her artwork from the Largo facility where displayed, LARGO may dispose of the property at its discretion.

IN WITNESS WHEREOF, the parties have executed this Agreement individually or by their duly authorized representatives.
